He also confirmed that they had managed to get some potholes filled in different parishes and commented on Litley/Bagginswood road and the large potholes etc.

 - ✓ Fly tipping round Harcourt 2 radiators and 2 motor wing mirrors.
 - ✓ Road already showing defect at Bagginswood photos will be sent to Clerk.
 - ✓ Potholes, top of Walton Bank right on the bend. Clerk has emailed regarding these today and awaiting further response from SC.
 - ✓ Potholes on bend by Prescott Farm.
 - ✓ Footpath at Yew Tree Farm still padlocked.
 - ✓ Smell from sewerage treatment lant at Chorley Severn Trent there working.
