3) Matters Arising:

a) Clerk's update:


happy to go through it with you if you would like me to, whilst you do it, I am around on Thursday and Friday this week if you would like me to help, please let me know.

6) SALC report:

Cllr Abbiss reported the following:

- White Paper discussed at SALC and response sent in.
- Zoom meeting today with SALC Exec a survey will be sent out after Xmas to find out how PC's have coped during the pandemic.
- Shortened AGM via Zoom on Friday 20th November if anyone wants to join in with 2 voting members allowed.
- Alan gave a talk on Carbon Neutral and has offered to join PC Zoom meetings.
- It had been suggested that delegated powers be given to Clerks and Chairman to complete any surveys sent during the pandemic. Cllrs **RESOLVED** to delegate powers to Clerk and Chairman to complete surveys.

Chairman thanked Cllr Abbiss for the report

7) Shropshire Councillor's report: sent out via email from both Shropshire Cllrs. Cllr Shineton hopes to join later.

8) Parish matters/problems:

- Fly tipping: Garden chair and exercise bench dumped by Duddlewick Bridge photos sent to SC this morning.
- Hinton Road the large pothole is dangerous 1 Cllr drove over this at approx 2mph and still scraped the bottom of his car. There are also numerous potholes further along this road together with deep mud (possibly 4" deep) on the road (not caused by Hinton Farm). This road is very well used with school taxis using this route.
- Sidbury Road from The Old Rectory to the junction to Upper House potholes and road slipping badly.
- Pickthorn Lane 2 large potholes
- Honeysuckle Brook road is being churned up very badly at present. We are told that maize
 being harvested from Fisk's fields at Aston Botterell are using the Hinton Road then turning
 off at the bottom of Station Road towards Hardwickforge then down Honeysuckle brook, up
 Oreton Bank then presumably using the Catherton Road coming out at Hillocks and on to the
 Biodigester south of Cleobury. These are no doubt contractors who completely fill the road
 with their tractors/trailers and have no respect for whatever damage they are causing and

- leaving thick mud on the roads. This needs looking into URGENTLY. We are told that they have made no effort at all to try to clean the roads.
- A 'ridge' appears to have formed in the road by Chorley Village Hall.
- Road between Loughton junction and Duddlewick floods and there are now more holes than surface!
- Thanks for getting the hedge cut on the bridge just before Halfway House Bank it was noted that the left-hand side coming from the Halfway House bank hasn't been cut.
- Can we please ask that when white linings have been replaced that the signs are removed say 'no white lines'. I know Kinlet area is one.
- The ROAD AHEAD CLOSED on the junction of the main Ludlow/Bridgnorth road is very confusing you can get to the Down before anything happens bridge closed? We saw cars/lorries turning on the junction last week. It's bad for businesses along this road i.e. Three Horseshoes, Boyne Arms and Pheasant at Neenton can all be accessed.
- Cllr Smith pointed out that during his 7 years living in the village many of the roads have become worse with not enough funding and money being spent on the 'A' roads not 'B' roads. Cllr Shineton agreed with this comment although we have had 1/2 jobs done very well – Bakers Bank, Walton Bank and Bagginswood-Prescott roads.
- The area around the notice board needs tidying up and the tree needs cutting back which is overhanging the Stotty Strolls noticeboard. RESOLVED to ask Mark Pearce to tidy this area as this was part if an 'enhancement programme' carried out by BDC.
- Numerous sycamore trees 'self-rooting' in Glebe Drive this is STAR Housing.
- Community First Responders Clerk had been asked to support Highley PC's request that
 the CFR's are sent out to all category emergencies as their calls have only been to Cat 1 and
 2 recently. It was RESOLVED that the Clerk writes to support this as they are vital in our
 communities.
- **7) Shropshire Clirs report:** Clir Shineton apologised for late arrival. Her latest report had been circulated to Clirs by Clerk and commented:
 - Principals of Future Fit on track, tweaked due to Covid but all parties working together.
 - Visiting hours time reduction for patients and relatives. This will cause mental health and well being problems in the future.
 - Highways survey urged to complete.
 - Cllr Shineton was asked what was happening with Shirehall. There are differing opinions on
 this building as this is considered to be an iconic 1960's building. Some feel SC should vacate
 and do something with the building while others felt that part of it could be rented off to i.e.
 the Police. Etc. 3 shopping malls in Shrewsbury have whole floors which could be used. Face
 to face meetings are needed to discuss this.
